# Commercial 10-Year Limited Warranty

# Warranty Coverage

This limited warranty applies exclusively to Lucciare Genesis surfaces installed in commercial properties, including offices, hotels, retail spaces, and rental units. It covers:

- □ Manufacturing and Material Defects: Such as structural flaws in the product.
- The warranty is valid only if:
- The product is fabricated and installed by an authorized Lucciare fabricator.
- The surface is permanently installed and remains unaltered from its original location.
- · Installation occurs in a qualifying commercial setting.
- Lucciare, at its sole discretion, will repair or replace the defective material.

# **Key Conditions**

## ■ Warranty Registration:

Must be completed within 30 days of installation at lucciare.com/warranty. If not registered, proof of purchase (invoice or receipt) is required.

#### □ Proper Maintenance:

The product must be maintained in accordance with Lucciare's official Care & Maintenance Guide.

#### □ Inspection Requirement:

All final determinations regarding warranty coverage will be made by Lucciare following inspection.

## Warranty Exclusions

This warranty does **not** cover:

## □ Fabrication or Installation Issues:

- Improper fabrication or installation (fabricator's responsibility).
- Seam failure caused by substrate movement, thermal shock, or unsupported overhangs.
- Modifications or fabrication outside of Lucciare's recommended guidelines (e.g., excessive mitering or thinning).

# Commercial 10-Year Limited Warranty

### ■ Damage from Misuse:

- Physical damage such as scratches, chips, or breakage due to impact or abuse.
- · Heat damage from placing hot items directly on the surface.
- · Chemical damage, dry cutting, on-site polishing, or unauthorized alteration.

## ■ Non-Qualified Applications:

- · Residential installations (covered under a separate warranty).
- · Outdoor use, flooring, mobile applications, or temporary installations.

#### Aesthetic and Natural Variations:

· Minor cosmetic imperfections, color or pattern variations, water spots, and stains.

## Limitations

## ■ No Consequential or Incidental Damages:

Lucciare is not liable for business interruption, lost revenue, or other indirect losses.

#### ■ Non-Transferable:

This warranty applies only to the original purchaser and becomes void upon transfer of ownership.

### ■ No Implied Warranties:

This warranty does not include any implied warranties, such as fitness for a particular use or promises made by others.

### Claim Process

## Report the Issue:

Email info@lucciare.com.au with details of the defect.

#### · Submit Documentation:

Provide proof of purchase (invoice or receipt) if the warranty was not registered.

## Inspection:

Lucciare or an authorized representative will evaluate the issue on-site.

#### Resolution:

If approved, Lucciare will repair or replace the defective material. Material availability may affect color or pattern matching.

# What's Covered

Fabrication and installation by authorized professionals

Valid for 10 years from installation date

Coverage available only to the original purchaser

# What's Not Covered

Exterior installations or structural movement

Physical abuse, misuse, or improper maintenance

Chemical damage, excessive heat, or impact

Unauthorized repairs or modifications

Normal wear and tear or surface dulling
